Course Description:

In this course we will study the field of statistics and econometrics. Statistics is the science that is concerned with data collection and analysis and with the decision-making process regarding the importance of the results. Statistics, like any tool, requires that the user understand the appropriate use of that tool and to develop some skill in using it. It is equally important and helpful to understand the concepts of statistics even if you do not plan to ever do research yourself. We are all consumers of statistics and hence it is critical to your education that you are competent consumers of statistics.

Econometrics is an extension of Statistics. It has been defined as "the application of mathematics and statistical methods to economic data" and described as the branch of economics "that aims to give empirical content to economic relations". Hence, put it simply, Econometrics involves formulating economic models in testable forms and estimating those models in an attempt to give empirical content to economic theory. An influential introductory economics textbook describes Econometrics as allowing economists "to sift through mountains of data to extract simple relationships."

Course Objectives:

This course is designed to offer students a starting point to understand deeper statistics and

econometrics theories and applications. Through learning the key concept of this course, students are expected to understand and apply some key statistical and econometric tools, such as the probability distributions, simple z-test, t-test, ANOVA, and multivariate regression models.

Student Learning Outcomes:

After successful completion of this course, students will be able to comprehend, interpret, apply and evaluate the following ideas:

- 1. Application of Probability theory.
- 2. Random Sampling and Probability Distribution.
- 3. Application of statistical hypothesis and testing.
- 4. ANOVA and MANOVA
- 5. An understanding of the structural of Economic Data.
- 6. Simple and Multivariate regression and OLS estimates.
- 7. An understanding of collinearity and spurious correlation and their implications on regression analysis.

Online Section Participation Guidelines

There are two categories of online section – online discussions and online assignments (including the final assignment). Please read the following guidelines carefully.

- Online Discussions: every student is required to post an online discussion with at least 250 ~ 300 word counts on the assigned topic and respond to at least one of others' postings. The response is required to have at least 100 ~ 150 word counts. Please post your discussions as early as possible during the week to let others have time to respond.
- Online Assignments: Students are required to answer the assigned questions thoroughly with required graphs and discussions. The discussions are required to have <u>at least 250 ~ 300 word counts per assignment</u>.
- The deadline for both online discussions and assignments is at 4:00pm on the due day. To ensure every student be treated fairly, late submission is barely accepted.
- All online assignments, <u>not</u> online discussions, are required to be submitted in a <u>Word document</u>. <u>No</u> other formats are acceptable.
- Final assignment: The final assignment is <u>comprehensive</u> and serves as the final exam of this course. Students are required to complete the assignment with <u>at least</u> <u>700 ~ 800 word counts</u>.
- Students are required to submit the assignments to <u>Knowledge/Blackboard</u>. Please <u>DO NOT</u> submit your work via email.
- Every submission will be graded within <u>7 working days</u> after the submission deadline. Once graded, the grade will be available in Knowledge/Blackboard and comments (if provided) will also be provided.
- The assignments are considered as individual work. Hence, students must <u>NOT</u> work on the assignments collaboratively. If violated, students will face University policy actions on Academic Dishonesty.

Course Grading Policy

1. Online discussion: Each online discussion accounts for 5% of the final course grade.

2. The online assignments will be graded based on a 100 scale. Each assignment accounts for 10%.

<u>NOTE: the lowest graded assignment (but NOT online discussion) will be automatically</u> <u>dropped.</u>

3. The final assignment occupies 25% of the course grade and it is graded on a 100 scale.

4. The final course grade is calculated as following:

Final Course Grade = [5 Online Discussion]*5% + [5 Online Assignments]*10% + Final Assignment*25%

UDM Policy on Plagiarism and Academic Integrity

Among the most serious academic offensives is plagiarism, submitting the style of another author or source without acknowledgment or formal documentation. Plagiarism occurs when specific phrases or entire passages, whether a sentence, paragraph or longer excerpt, are incorporated into one's own writing without quotation marks or documentation. One also plagiarizes by paraphrasing the work of another, that is, retaining another writer's ideas and structure without documentation.

Students are advised always to set off another writer's exact words by quotation marks, with appropriate references. Students avoid plagiarism by concentrating on their own words and ideas and by fully crediting others' words and ideas when they find their way into the writing. Whenever in doubt, cite the source.

Students that purchase essays from other students or agencies or who copy from one another or from prohibited sources, commit the most serious type of academic dishonesty. The consequences of

plagiarism, or any act of academic dishonesty, may range from failure on an assignment or in a course to dismissal from the University.

Disability Support Services and Accommodations:
