Elizabeth Hill, PhD joined the University of Detroit Mercy faculty in 1997. She received her Doctorate in Experimental Psychology from Tulane University. She taught courses in research methods, statistics, biopsychology and gender differences. Her primary areas of research interest and activity focused on evolutionary and comparative psychology. She has investigated the interaction between biological and environmental factors in risk-taking behavior. In this research, Hill used evolutionary theory related to parental investment and life history strategies to conceptualize environmental factors, especially the impact of an unpredictable family environment. She received the University of Detroit Mercy Distinguished Faculty Award in 2010. She retired with the honor of Professor Emerita in 2021.

Cheryl Munday, PhD holds a Bachelor of Arts from Cornell University. She earned her PhD in Clinical Psychology from the University of Michigan. She joined the University in 1997. Dr. Munday served as a Professor of Psychology and Director of Developmental Psychology, taught case conference, child therapy and professional ethics in the doctoral program and personality theory in the undergraduate major program. She also served as the Director of the Detroit Mercy Psychology Clinic. Her research interests have included behavioral correlates of object relations and defensive functioning in children and racial and ethnic influences in clinical judgment. Her research has been funded by the United Way and the National Institute of Mental Health. She is the former Director of Psychology and Psychology Training at Detroit Psychiatric Institute, which offered both practicum placements and an APA accredited predoctoral internship. She is affiliated faculty with the Program for Research on Black Americans, Institute for Social Research. She retired in 2020.

Margaret Stack, PhD, ABPP was an Associate Professor of Psychology. She received a Bachelor of Arts from the University of Michigan and her Doctorate in Clinical Psychology from the University of Detroit. She is a Diplomate in Clinical Psychology from the American Board of Professional Psychology (ABPP). She joined the University faculty in 1995. She taught courses in assessment, basic psychoanalytic concepts, human sexuality, religion and psychology, and case conference. Her primary areas of research interest include LGBT issues, spirituality, and delinquent behavior in adolescents. Her current research focuses on understanding the complexity of factors that contribute to youth violence, juvenile sexual offending, and/or other delinquent behavior. Stack's clinical work is directed at psychotherapy with adults and families, and psychological assessment of children, adolescents, and adults. She has been a consultant to the Oakland County Circuit Court – Family Division, where her services include psychological evaluation of adjudicated delinquents and individuals referred because of neglect and/or abuse, domestic relations, competency evaluations, expert witness services, and staff training. Stack is also a member of the Archdiocesan Review Board, which is an advisory board for cases of clergy sexual abuse for the Archdiocese of Detroit. She retired in 2019.

Sharla Fasko, PhD served as Associate Professor and Director of the School Psychology Program at the University of Detroit Mercy. She taught courses in psychoeducational interventions and applied behavior analysis. Formerly President of the Kentucky Association for Psychology in the Schools, Dr. Fasko is a licensed psychologist and a nationally-certified school psychologist. She holds a Bachelor of Music Education from Henderson State University, a Master of Education from Southern Arkansas University, and her Doctorate from the University of Cincinnati. Fasko joined the Department of Psychology faculty in the fall of 2008. She has also been devoted to her love of theater. She retired in 2021.

Libbey Balter Blume, PhD Professor of Psychology, Blume taught courses in child development, family relations, environmental psychology, creativity and giftedness, architecture and community development, and women's and gender studies. She directs the undergraduate programs in Developmental Psychology and Certified Family Life Education and co-directed the Community Development graduate program. Blume is a Fellow of the National Council on Family Relations and past recipient of the Award of Excellence from the U.S. Department of Health and Human Services. Blume's research interests are adolescents' social constructions of gender and ethnicity and feminist theory in family studies. She co-authored two textbooks on middle childhood and adolescence, was editor-in-chief of the *Journal of Family Theory & Review*, and was founding editor of the *Michigan Family Review* and the *Groves Monographs on Marriage & Family*. Founder of the Women's and Gender Studies Biennial Art Exhibition, Blume also has a background in fine arts and creative arts education. She has extensive experience as an art educator, preschool teacher, child development center director, and consultant to Head Start programs and to schools for gifted children from elementary to high school. She holds a Bachelor of Arts from the University of California at Davis, a Master of Arts from San Francisco State University, and a Doctorate from Texas Tech University. She came to Detroit Mercy in 1987 and also served as an Adjunct Professor for University of Detroit Mercy's School of Architecture. She retired with the honor of Professor Emerita in 2018.

Carol Cronin Weisfeld, PhD taught courses in human development, human sexuality, sex differences and sex roles, cross-cultural psychology and health psychology. She co-authored one edited book, and her research on male/female relations has appeared in such journals as *Genetic Psychology Monographs* and *Archives of Sexual Behavior*. Her current research concerns marital satisfaction in the U.S., England, Turkey, Russia, and China. "The Psychology of Marriage: An Evolutionary and Cross-Cultural View," published by Lexington books in 2018, summarized that research. At Detroit Mercy, she was active in university governance, providing leadership service to the faculty union and the McNichols Faculty Assembly. She received her Ph.D. from the University of Chicago. She was selected as the 1994 recipient of the President's Award for Faculty Excellence at Detroit Mercy. She received Detroit Mercy's Distinguished Faculty Award in 2004. She joined the University (Mercy College of Detroit) in 1979 and retired with the honor of Professor Emerita in 2018.

Lee R. Eshelman, PhD is a licensed clinical psychologist and Assistant Professor in the Department of Psychology at University of Detroit Mercy. Prior to joining the faculty in 2019, she earned her Ph.D. in Clinical Psychology from Miami University. She completed an APA accredited clinical psychology internship at University of Wisconsin – Department of Psychiatry, and a postdoctoral fellowship in Women’s Health with the University of Michigan Medicine/VA Ann Arbor Consortium. Eshelman is the Director of the Trauma, REsilience, and Empowerment (TREE) Lab at University of Detroit Mercy. Broadly, her research program focuses on understanding the impact of trauma on coping, resilience, and psychological outcomes such as posttraumatic stress disorder (PTSD) and substance use. Her work aims to explore the complex mental health sequelae following traumatic experiences, to inform strengths-based advocacy for trauma survivors, and to refine evidence-based approaches for culturally informed intervention. Her research has largely focused on interpersonal violence and sexual assault, although her research and clinical interests lie in all forms of trauma. At University of Detroit Mercy, Eshelman teaches graduate and undergraduate courses. She is committed to providing strengths-based professional development support to all students with diverse interests and career goals.



Emily A. Dowgwillo, PhD earned her Ph.D. in Clinical Psychology from Pennsylvania State University. Dowgwillo joined the University of Detroit Mercy in 2020 after completing her clinical internship at Massachusetts General Hospital. She teaches psychology to undergraduate and graduate students and has been appointed the Associate Director of the Psychology Clinic. Dowgwillo's program of research examines the between and within personal assessment of co-occurring personality dysfunction, psychopathology and interpersonal dynamics in daily life, with the ultimate goal of identifying person specific interventions that can be administered in the moment using smartphone technology. In pursuing these research domains, she relies on intensive longitudinal data (e.g. using ecological momentary assessments) and utilizes advanced quantitative methods such as multilevel models, parallel process growth curve models, structural equation models, and person-specific (i.e. idiographic) models.

Sarah Stebbe Rowe, PhD is an Assistant Professor of Psychology and a Nationally Certified School Psychologist (NCSP). Prior to joining University of Detroit Mercy in 2021, Rowe worked as a school psychologist and Multi-Tiered System of Support (MTSS) coordinator in the metro-Detroit area for nearly a decade. Rowe earned her Doctoral degree in School Psychology from Michigan State University. She teaches undergraduate and graduate psychology courses and supervises the field experience for first-year school psychology graduate students. Her research examines teacher's use of and attitudes toward universal screening and progress monitoring data within the MTSS model. Previous research and teaching awards include the competitive Society for the Study of School Psychology Dissertation Grant and Honorable Mention in the MSU AT&T Fully Online Course: Award of Excellence.



Miao Qian, PhD (pronounced Mee-Aw, Chi-en) earned her Ph.D. in Developmental Psychology and Education from the University of Toronto, Canada. Qian joined the University of Detroit Mercy in 2021 after completing two years of postdoctoral psychology training in the Inequality in American Initiative program at Harvard University. Qian teaches graduate and undergraduate courses in developmental psychology. Her research interest is in child social cognition, to answer the questions about how children acquire knowledge of social categories, such as race and gender, and how they use the knowledge to perceive, evaluate and judge others. Qian's research spans across developmental and social psychology, using methodologies and theories from cognitive, social-cognitive and developmental psychology. She currently has two lines of research: (1) The origin and root of implicit intergroup bias and the social-cognitive factors that drive bias development; (2) the malleability of implicit social biases, such as racial bias and gender bias, and interventions to reduce them in childhood.

Supervisor and Adjunct Faculty Spotlight

Highlighting the work of a few of our supervisors and adjunct faculty!



Ray Kamoo attained his PhD in Clinical Psychology from the University of Detroit Mercy in 1999, after having completed an internship at Sinai Hospital-Detroit Medical Center. After graduation, he began Apex Therapy Services to provide comprehensive therapy and assessment services to children and adults. Since those beginnings, Apex now serves patients at their offices in Bingham Farms and Trenton. Recently, psychiatric services have been added. Psychological assessments include dementia, return to work, ADHD, immigration evaluations, and many others. A recent endeavor has involved testing children and adolescents who lived in Flint during the water crisis, to better assess whether they may have been affected by the toxic amounts of lead in the water. Several UDM students continue to be involved in this important project.

Dr. Park a fully Licensed Psychologist in the state of Michigan for the past 10 years. He graduated from the University of Detroit Mercy Ph.D. program in 2001. Since obtaining his PhD, he has worked as an independent practitioner and his clinical work has involved the practice of outpatient psychotherapy, as well as administering psychological evaluations in a variety of domains such as academic/ADHD evaluations, court ordered evaluations, and evaluations involving custody and parenting time issues. He has extensive experience as a Clinical and Forensic Psychologist in diverse settings including outpatient, inpatient, emergency room, and residential treatment facilities. He has been in private practice in Dearborn, MI for the past 10 years conducting both psychotherapy and psychological evaluations. His work with children, adolescents, and adults involves helping individuals and families address a wide variety of difficulties including anxiety, depression, ADHD, and anger. He has taught the Assessment practicum (PYC 6730) to the doctoral students as well as having taught Child Assessment (PYC 5230).



Dr. Soldz is a professor, clinical psychologist, and psychoanalyst with a specialization in research methodologies. He has been a faculty member of the Boston Graduate School for Psychoanalysis since 1989. He has taught at Boston University, Boston College, Harvard Medical School, and the University of Massachusetts, Boston. During the 2016-2017 academic year he was a Fellow-in-Residence at the Edmond J. Safra Center for Ethics at Harvard University. Dr. Soldz has been research director of several nonprofit and for-profit consulting organizations. He has consulted to federal, state, and local governments, as well as corporate and nonprofit organizations, including the Department of Defense, the North Carolina Department of Corrections, and the Massachusetts Department of Public Health. His research has focused on research methodologies, substance abuse, tobacco control, personality, lifespan development, and psychotherapy research. From 2006, Dr. Soldz has been a leader in a movement to remove psychologists from sometimes abusive national security interrogations and to change the American Psychological Association's (APA) permissive policies allowing that involvement. He taught Ethics (PYC 6930) for the doctoral program in 2021 and 2022.

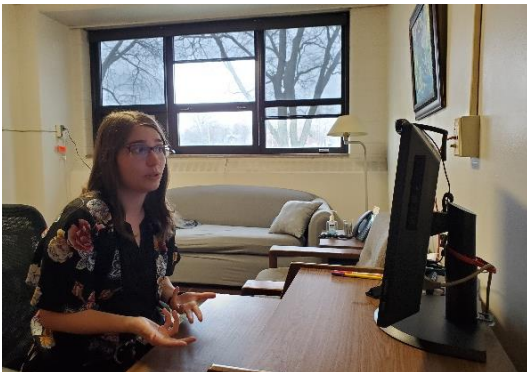

COVID-19 Status Reports

When the COVID-19 pandemic began in March 2020, the University of Detroit Mercy shut down in-person operations and classes and the Psychology Clinic needed to move to virtual platforms. COVID-19 impacted students at practicum and internship positions as well. The University made many adjustments throughout the pandemic. Initially, classes took place on Zoom, and psychotherapy took place on Doxy or by phone. In August 2020, professors were able to resume in-person teaching, with everyone wearing masks. Supervision sessions took place virtually and depending on the supervisor and student, have either resumed in-person or have continued online. Faculty and graduate students persevered and continued with instruction and clinical rotations in-person, while following the CDC and MPA COVID-19 guidelines.

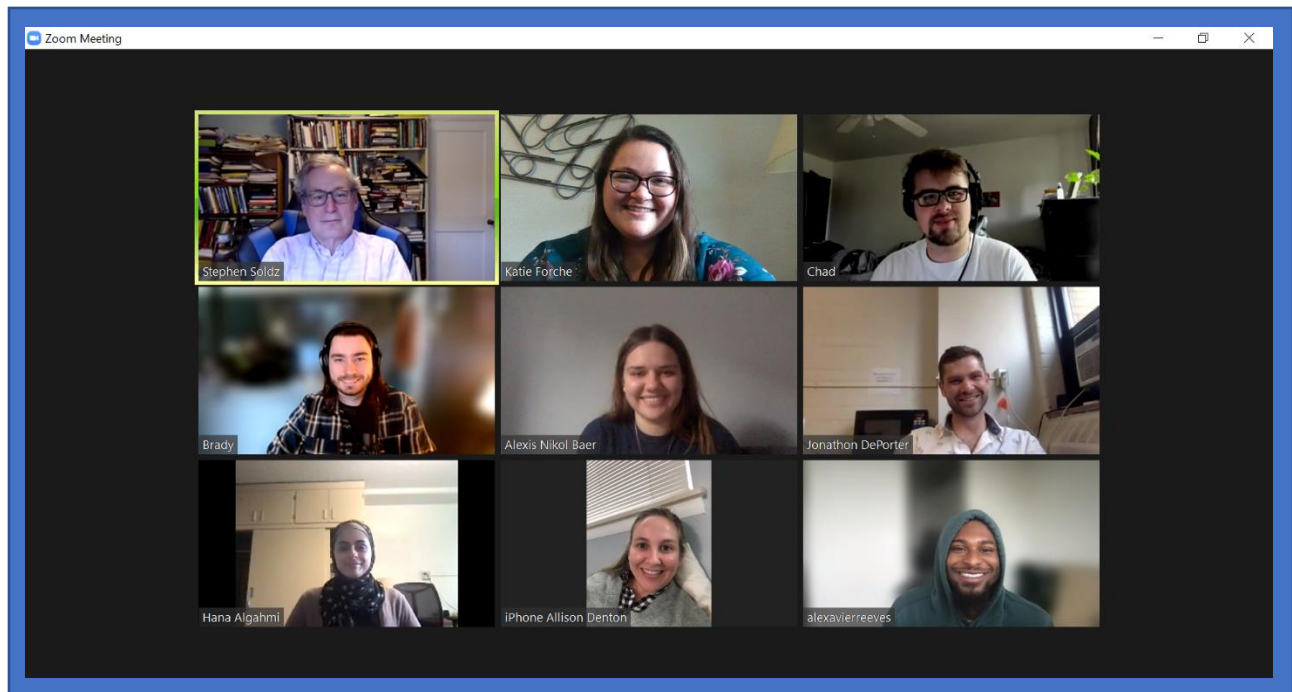

COVID-19 Status Reports

The pandemic encouraged creative solutions in the academic and clinic settings. When in need of a professor to teach the graduate Ethics course, the scope of professors considered could be broader than Michigan because remote-learning was more readily utilized. Dr. Stephen Soldz is nationally known for his commitment to ethical practices, especially his work in the context of examining the interrogation procedures at Guantanamo Bay. He is a faculty member at the Boston Graduate School of Psychoanalysis and currently resides in Boston. He has taught the Detroit Mercy Ethics and Professional Issues course for the past two years and has conducted class through Zoom. The pandemic has allowed for unique opportunities, such as having a renowned psychoanalyst with a strong ethics background in Boston, Massachusetts teach students in Detroit, Michigan.

Visiting Professor 2022

John Porcerelli, PhD, ABPP



John Porcerelli, PhD, ABPP is a Professor of Psychology in the Doctoral Program in Clinical Psychology at the University of Detroit Mercy. Prior to 2016, he served as Professor & Director of Behavioral Medicine, Department of Family Medicine & Public Health Science at Wayne State University School of Medicine. Neville Symington, B. Sc (July 1937 - December 2019) was a Fellow of the British Psycho-analytic Society, a member of the Australian Society and an Honorary Member of the Israeli Psychoanalytic Society. At the time of the Visiting Professor presentation, he was a psychoanalyst practicing in Sydney, Australia. He was awarded the Sigourney Award in 2013, an International Award, which recognizes individuals or organizations who are making significant advances in clinical psychoanalysis, psychoanalytic research, and applied psychoanalysis. He held many esteemed professional positions internationally and published approximately 15 books and written numerous published articles. While Neville Symington contributed in many ways, he made distinct contributions though his novel understanding of Narcissism and to the Psychology of the Person. He authored 14 books on widely ranging subjects, including narcissism, psychoanalysis and religion, madness, and becoming a person through psychoanalysis.

CLINICAL PSYCHOLOGY PROGRAM TO BENEFIT FROM \$1.07M GRANT

Over the past year, Drs. Steven Huprich and Barry Dauphin have been working with the Boys and Girls Club of Southeastern Michigan (BGCSM) to develop a clinical training opportunity for doctoral students interested in working with economically disadvantaged and minority children and adolescents. In partnership with BGCSM, Wayne State University (Drs. Douglas Barnett and Marilyn Franklin), and Michigan School of Psychology (MSP; Drs. Heidi Martin and Jim Maher), Dr. Huprich spear-headed the development of this mental health initiative across three institutions. This initiative led to hiring Dr. Tiffany Abrego, who will lead the practicum involving six doctoral students. Drs. Barnett and Franklin from Wayne State University took the lead on writing up a Graduate Psychology Education (GPE) grant, entitled “Integrated Health Services for Detroit Youth.” Funded through the Health Resources and Services Administration, the grant requested \$1, 066, 000 in funding to support the program infrastructure and salary support for supervision and clinical students. This grant is also multidisciplinary in nature and will integrate students and faculty from Detroit Mercy’s nursing program and Wayne State’s social work program.

On June 2, 2022, Drs. Huprich and Dauphin were informed that the grant was funded! Student recruitment for the practicum is already underway, and it is anticipated that Detroit Mercy, Wayne, and MSP students will begin working at two of the five BCGSM locations sometime during 2022. The grant has been funded for three years. The BGCSM describes itself as a “safe space for youth to learn and have fun, while providing them with the economic, cultural and social capital needed to become career, start up and homeowner ready.” More information about the club can be found at www.bgcsm.org.

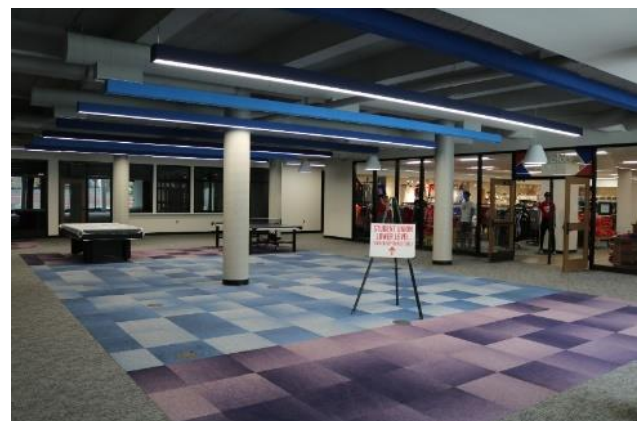
